**STATE ROAD (S.R.) 7 EXTENSION PROJECT**

From S.R. 704/Okeechobee Boulevard to Northlake Boulevard  
Palm Beach County, Florida  
Financial Project Identification Numbers: 229664-6 and 229664-7

The Florida Department of Transportation (FDOT) will conduct a public meeting for the above referenced project within Palm Beach County. This public meeting will be offered virtually and in-person. The public meeting will have representatives available to answer questions. Project information will be available for public viewing. Questions and comments may be submitted prior to the meeting by contacting the Project Manager, Scott Peterson, P.E.. **PURPOSE OF PROJECT:** Extend S.R. 7 to provide a safe, efficient, and environmentally sensitive connection between Okeechobee Boulevard and Northlake Boulevard to improve community connectivity for western Palm Beach County.

**PROPOSED IMPROVEMENTS**

**229664-7 (from Okeechobee Boulevard to 60th Street)**

- Construct two new travel lanes between Okeechobee Boulevard and 60th Street to provide two lanes in each direction.
- Modify the 60th Street roundabout from a one-lane to a two-lane roundabout.

**229664-6 (from 60th Street to Northlake Boulevard)**

- Construct a four-lane divided roadway on a new alignment from 60th Street to Northlake Boulevard.
- Construct new 4-lane bridge crossings over the M-Canal and the Ibis Preserve spillway.
- Construct a 12-foot shared-use path from 60th Street to Northlake Boulevard to improve bicycle and pedestrian safety and mobility.
- Construct a robust drainage system to improve the resiliency of our infrastructure.

**CONSTRUCTION IMPACTS**

- Work will be done in phases to reduce the effects of construction on the community.
- Short-term, temporary detours are anticipated for construction of connections to Orange Grove Boulevard and Persimmon Boulevard. Both will be limited to one weekend each, and will not occur at the same time.
- Access to businesses and residences will be maintained during construction.
- Another public meeting (Construction Open House) will be held prior to construction. Detailed information about how to keep informed of potential construction impacts will be provided at that meeting.

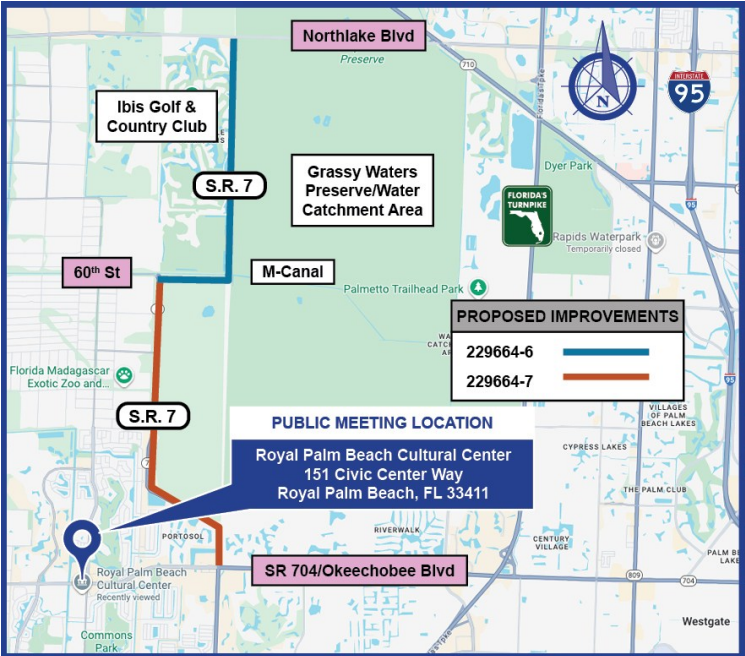
