From State Road (SR) 704/Okeechobee Boulevard to Northlake Boulevard
 Palm Beach County, Florida

The Florida Department of Transportation’s (FDOT) SR 7 Extension Project will provide a safe, efficient, and environmentally sensitive connection between Okeechobee Boulevard and Northlake Boulevard to improve community connectivity for western Palm Beach County. This project is vital to satisfying capacity and mobility needs due to increasing growth and travel demands in the region. The improvements will also help with emergency response and evacuation by improving network connectivity in the area.

PROJECT IMPROVEMENTS

229664-7 (from Okeechobee Blvd to 60th St)

- Adding two new travel lanes with bike lanes between Okeechobee Blvd and 60th Street to provide two lanes in each direction.
- Reconstructing the 60th Street roundabout from a one-lane to a two-lane roundabout.

229664-6 (from 60th St to Northlake Blvd)

- Constructing a four-lane divided roadway on a new alignment from 60th Street to Northlake Blvd.
- Constructing crossings over the M-Canal and the Ibis Preserve spillway.
- Constructing a 12’ shared-use path from 60th Street to Northlake Blvd to improve bicycle and pedestrian safety and mobility
- Constructing a robust drainage system to improve resiliency

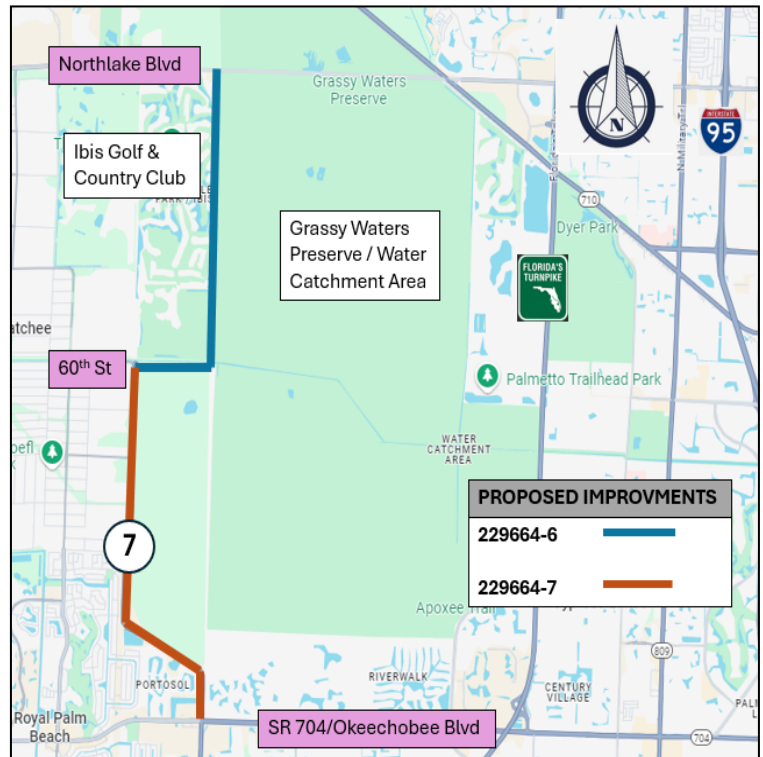
CONSTRUCTION IMPACTS

- Work will be conducted in phases to minimize construction impacts.
- Short-term, temporary detours are anticipated for construction of connections to Orange Grove Blvd. and Persimmon Blvd. Both will be limited to one weekend each, and will not occur at the same time.
- Business and resident access will be maintained throughout construction.

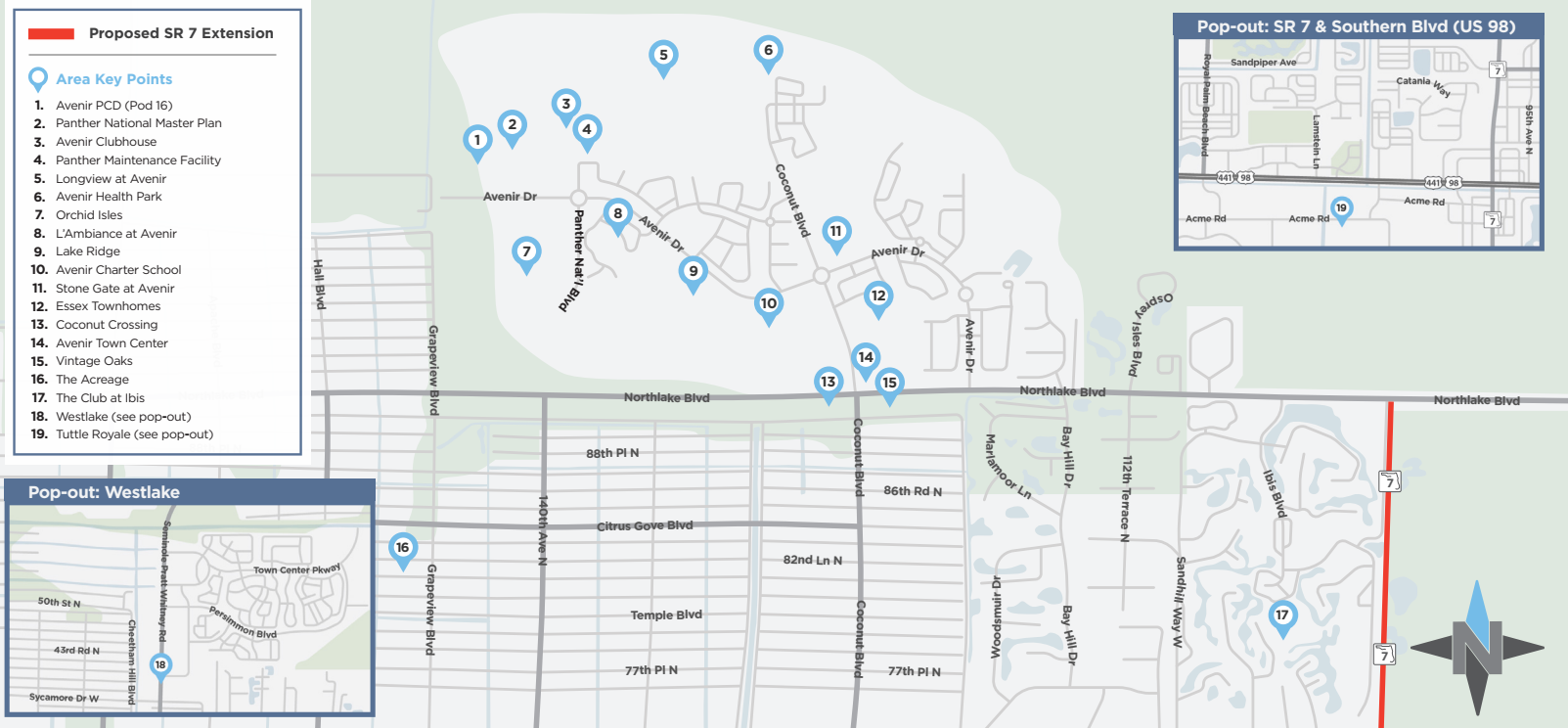

PROJECT KEY POINTS

IMPROVE REGIONAL TRAVEL CONNECTIVITY

- There are limited north-south corridors in the western Palm Beach County network.
- SR 7 is one of four roads that connect between Miami-Dade, Broward, and Palm Beach Counties.

ACCOMMODATE THE TRAVEL DEMAND

- The need for additional linkage between Okeechobee Blvd and Northlake Blvd will continue to grow as travel demands grow.

SATISFY CAPACITY, MOBILITY, AND CONNECTIVITY NEEDS

- In addition to travel demand, the route will facilitate hurricane evacuation and emergency response times.
- The SR 7 Extension project adds four lanes of north-south roadway traffic capacity between 60th Street North and Northlake Blvd. and two lanes of north-south roadway traffic capacity between Okeechobee Blvd and 60th Street North.
 - This extension will help alleviate traffic volume on adjacent north-south parallel roads including Seminole Pratt Whitney Road, Royal Palm Beach Blvd., Coconut Blvd., and the Florida Turnpike.

DISTANCE AND TRAVEL TIME BENEFITS

- The SR 7 extension provides a longer route and shorter drive times than other parallel routes.
- Travel demand shows a need for another north-south route in Palm Beach County.
 - Data shows an increase in population by 50% from 2015-2045 and a job growth increase of 73%.
 - Three new developments in western Palm Beach County including Avenir, Minto West, and Indian Trails Grove relied on the SR 7 extension to accommodate their trips.

INCREASE SAFETY

- Reduce cut-through traffic in the residential streets of the Acreage, most notably Royal Palm Beach Blvd and Coconut Blvd.
- The SR 7 Extension route reduces the total overall predicted number of crashes on the adjacent north-south roads in the study area.
